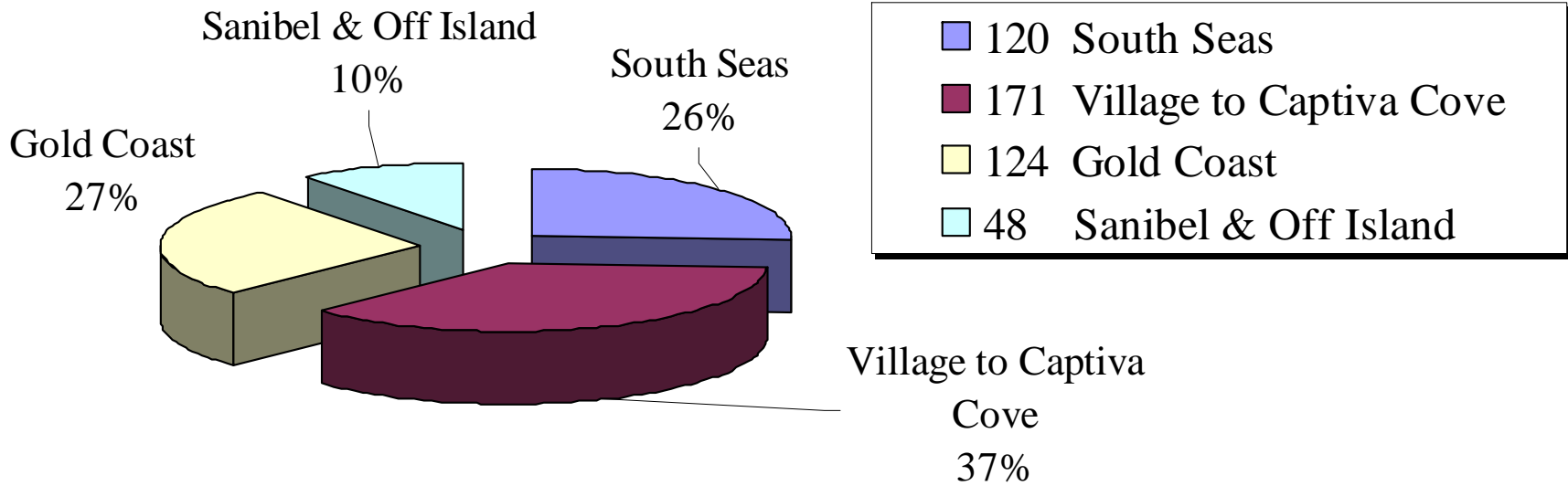

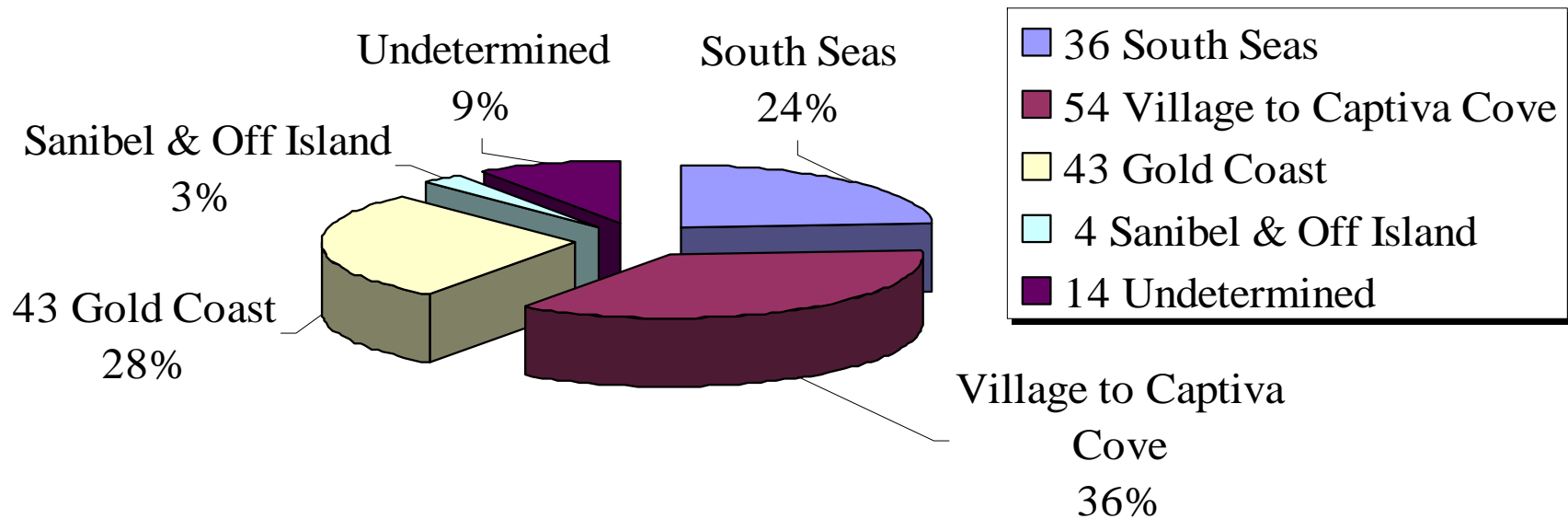

CCA Membership by Island Location

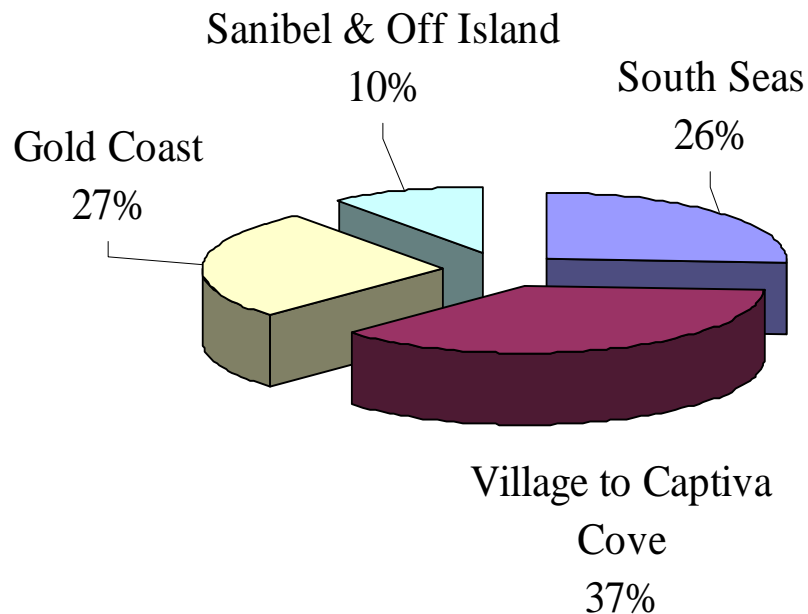


CCA Member Responses by Island Location

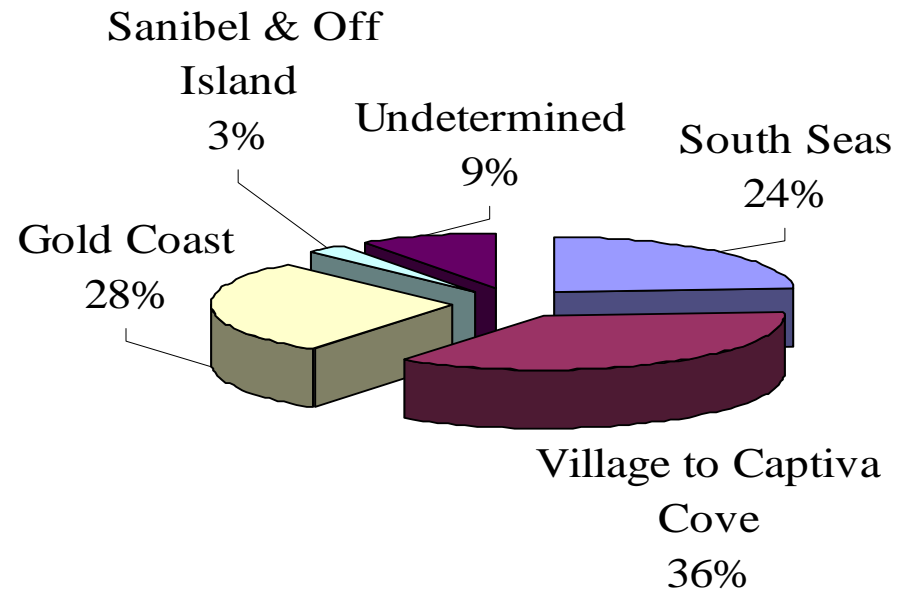

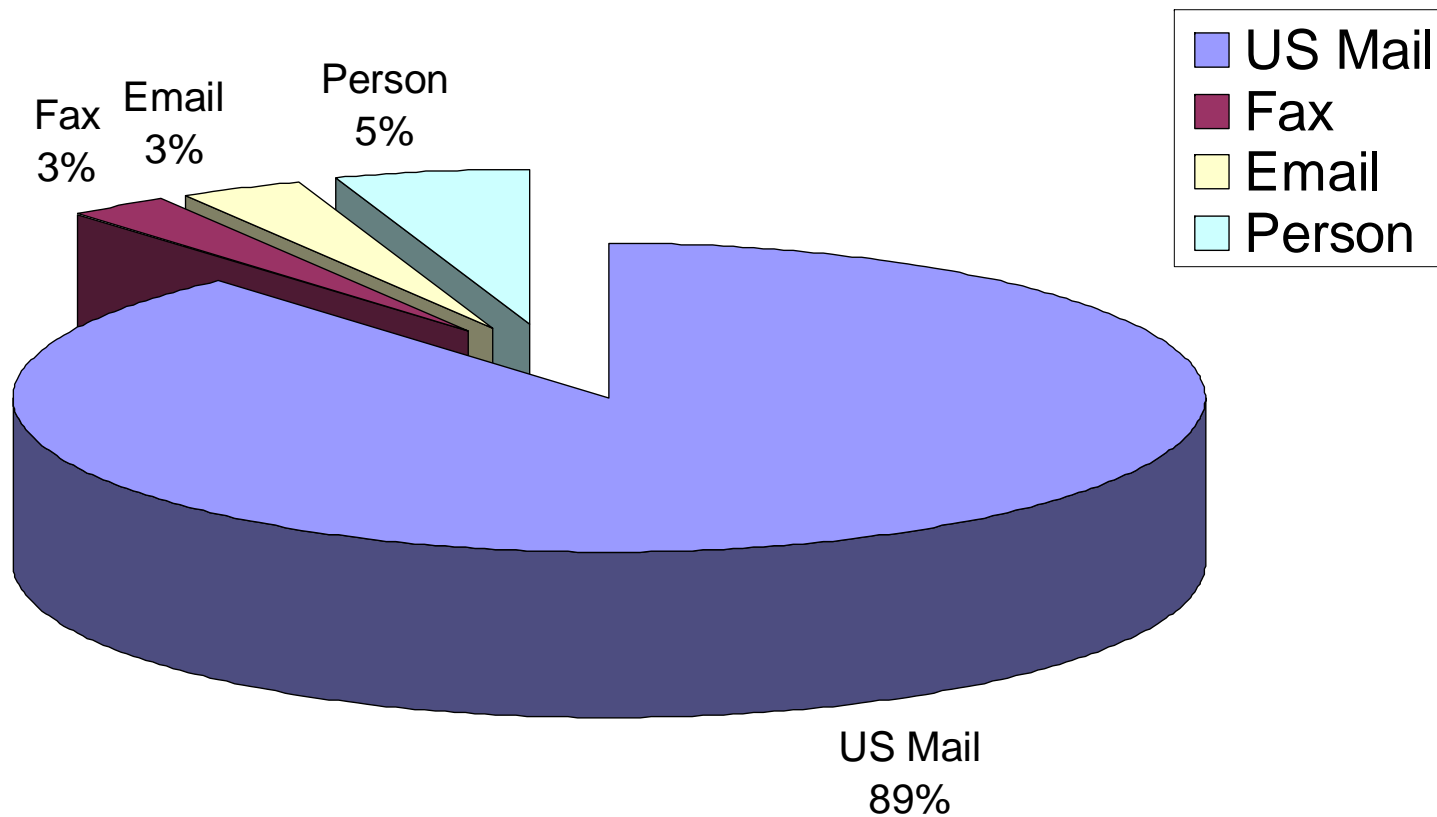

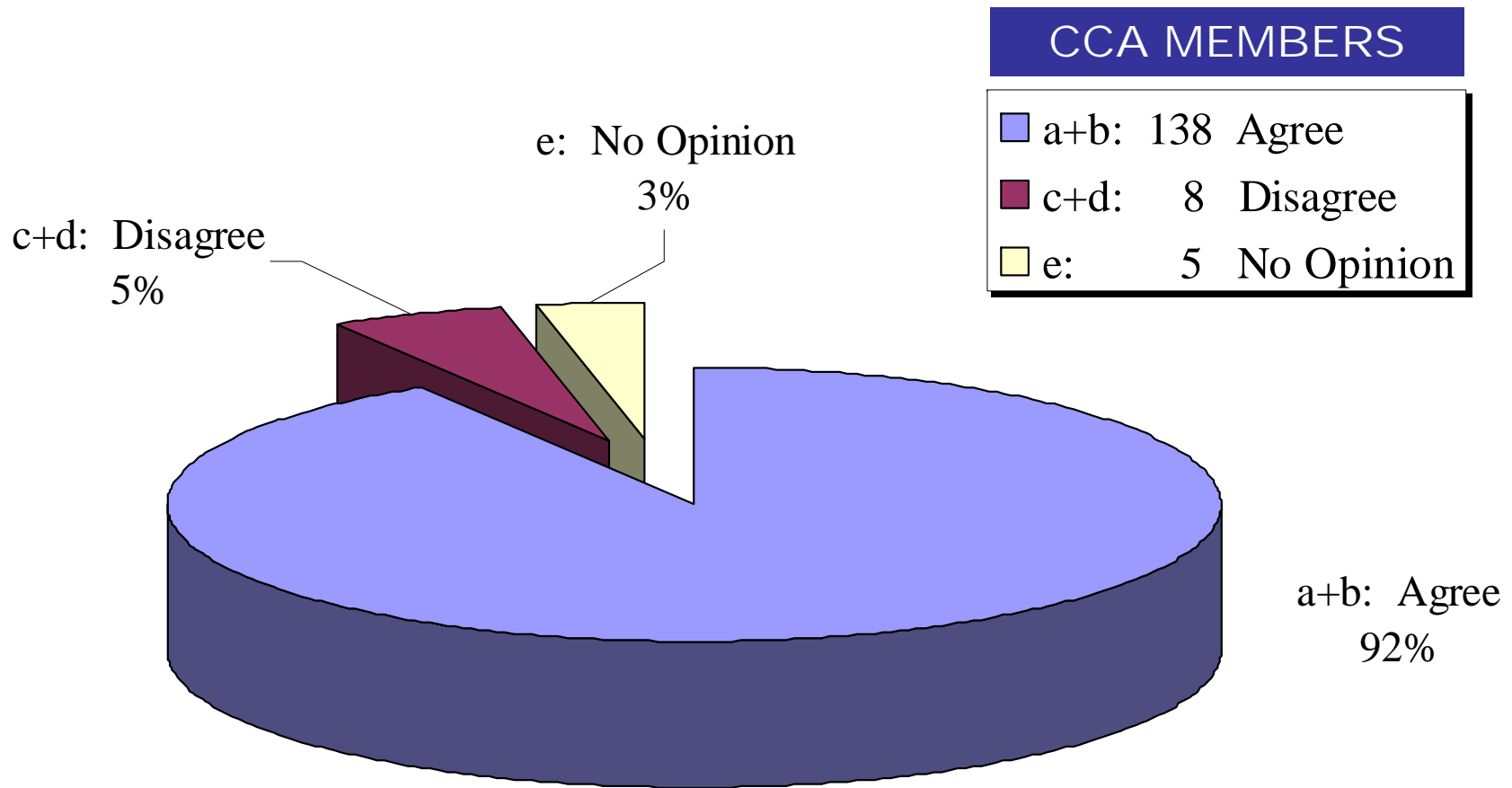

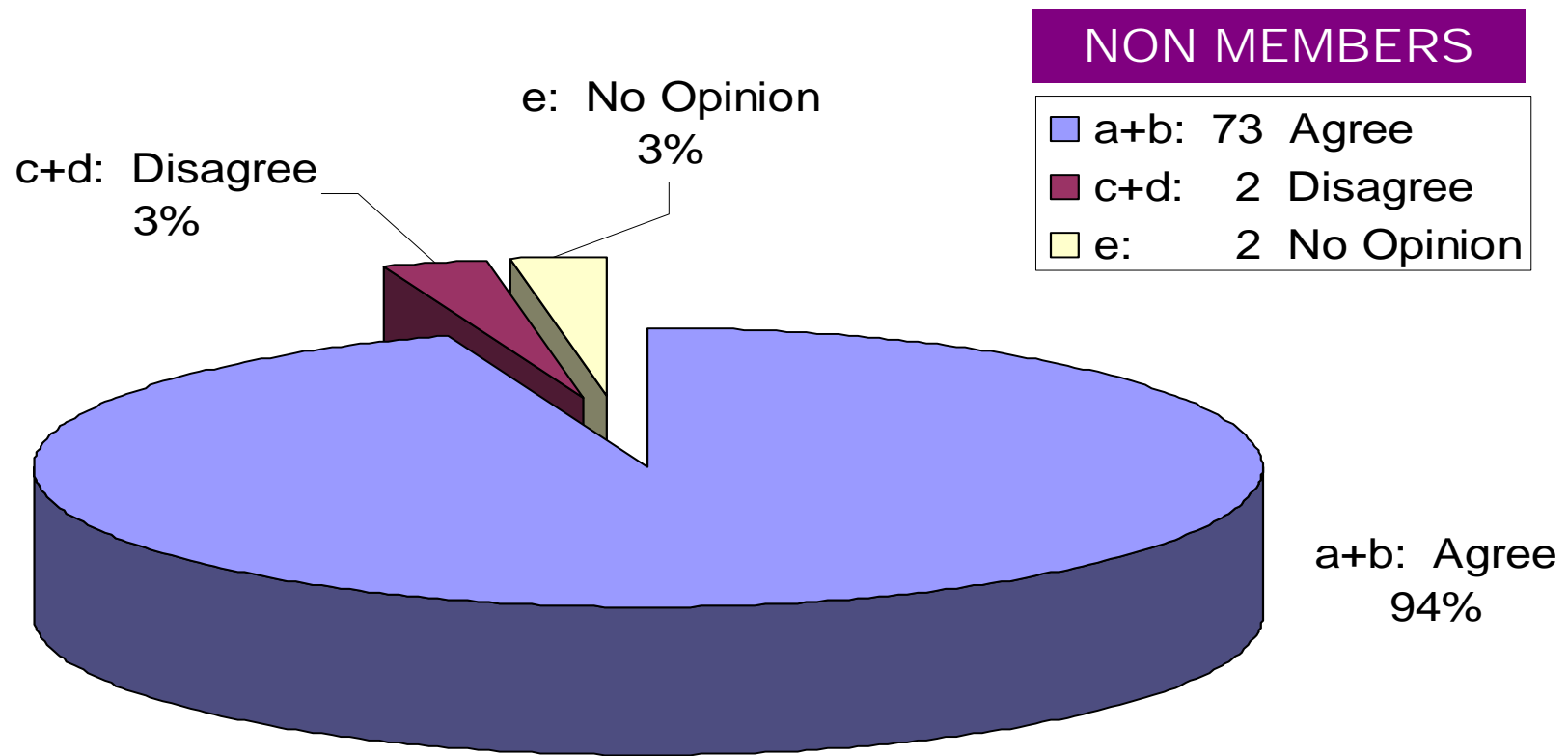

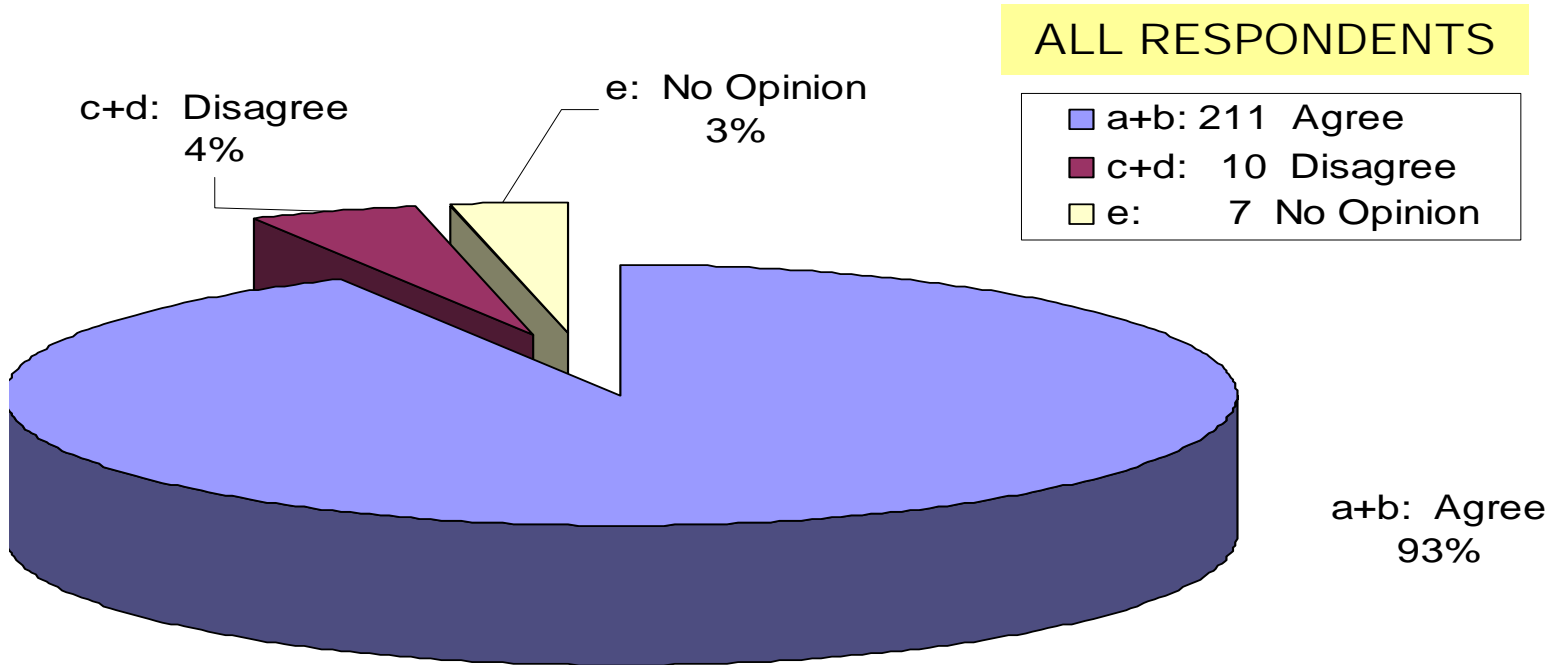
Land Use - Zoning Agree or Disagree?



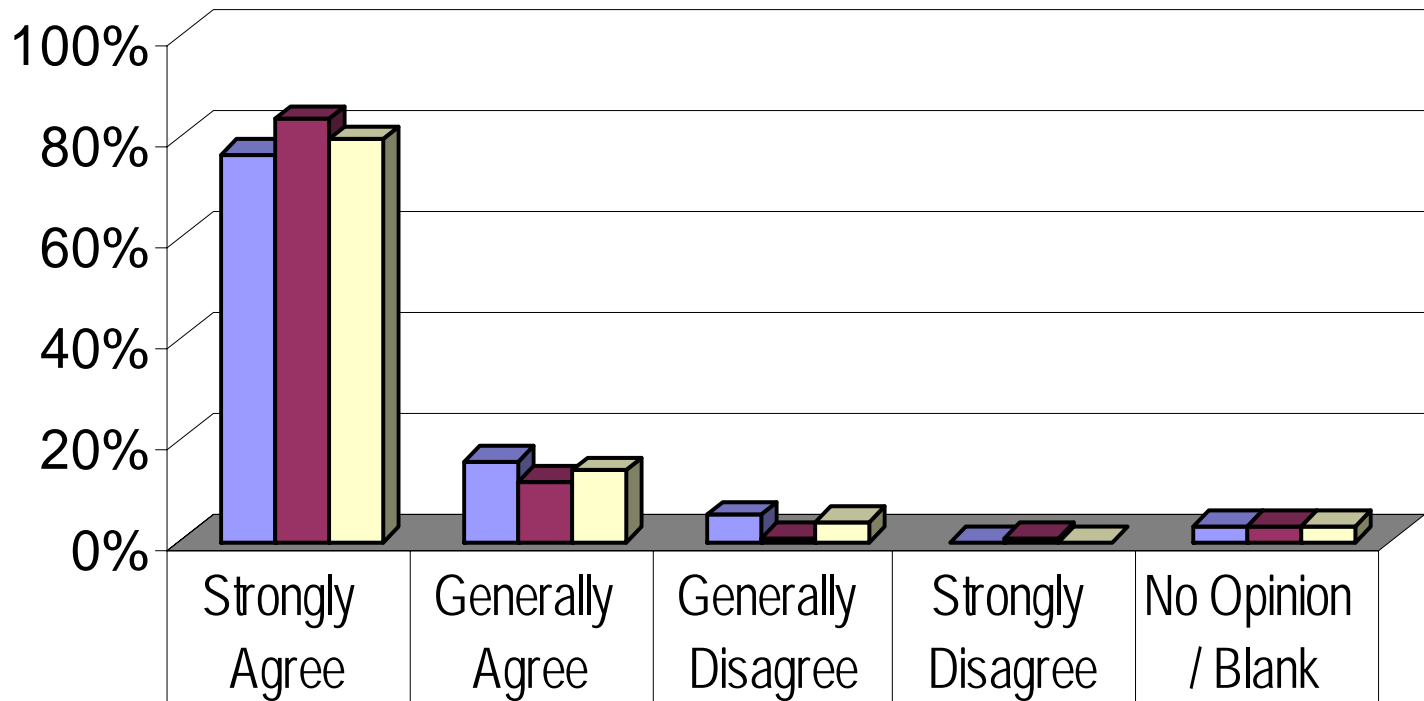
Land Use - Zoning Agree or Disagree?

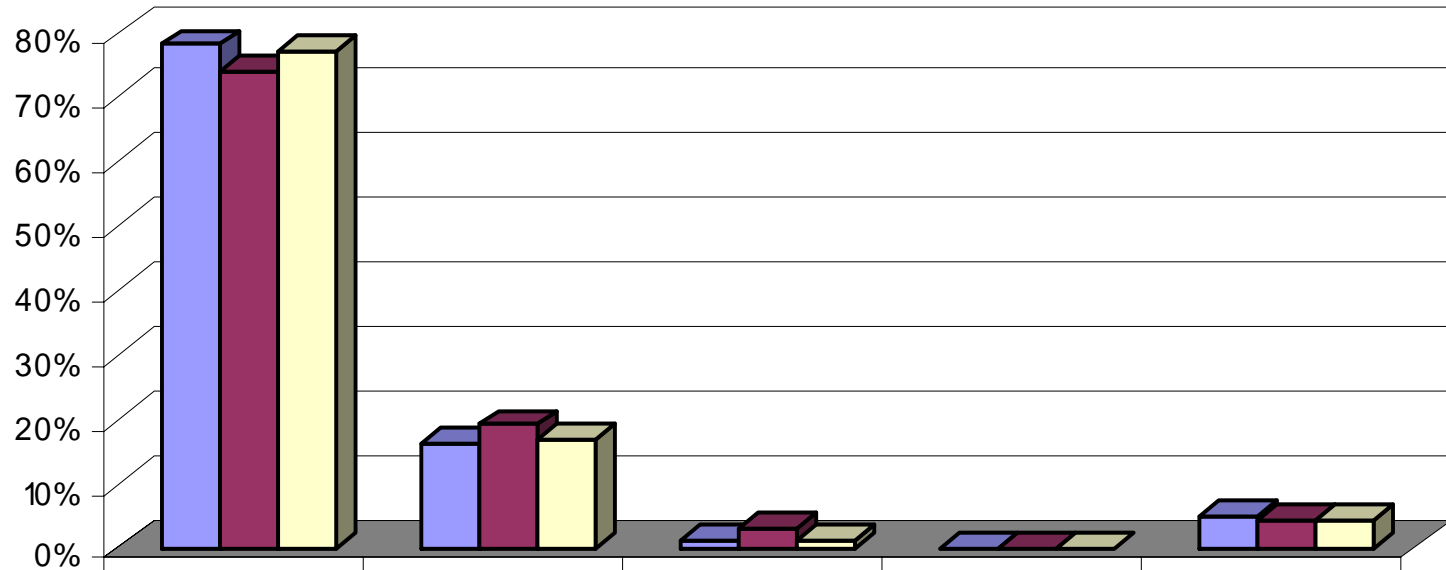
Transparent Representation Agree or Disagree?

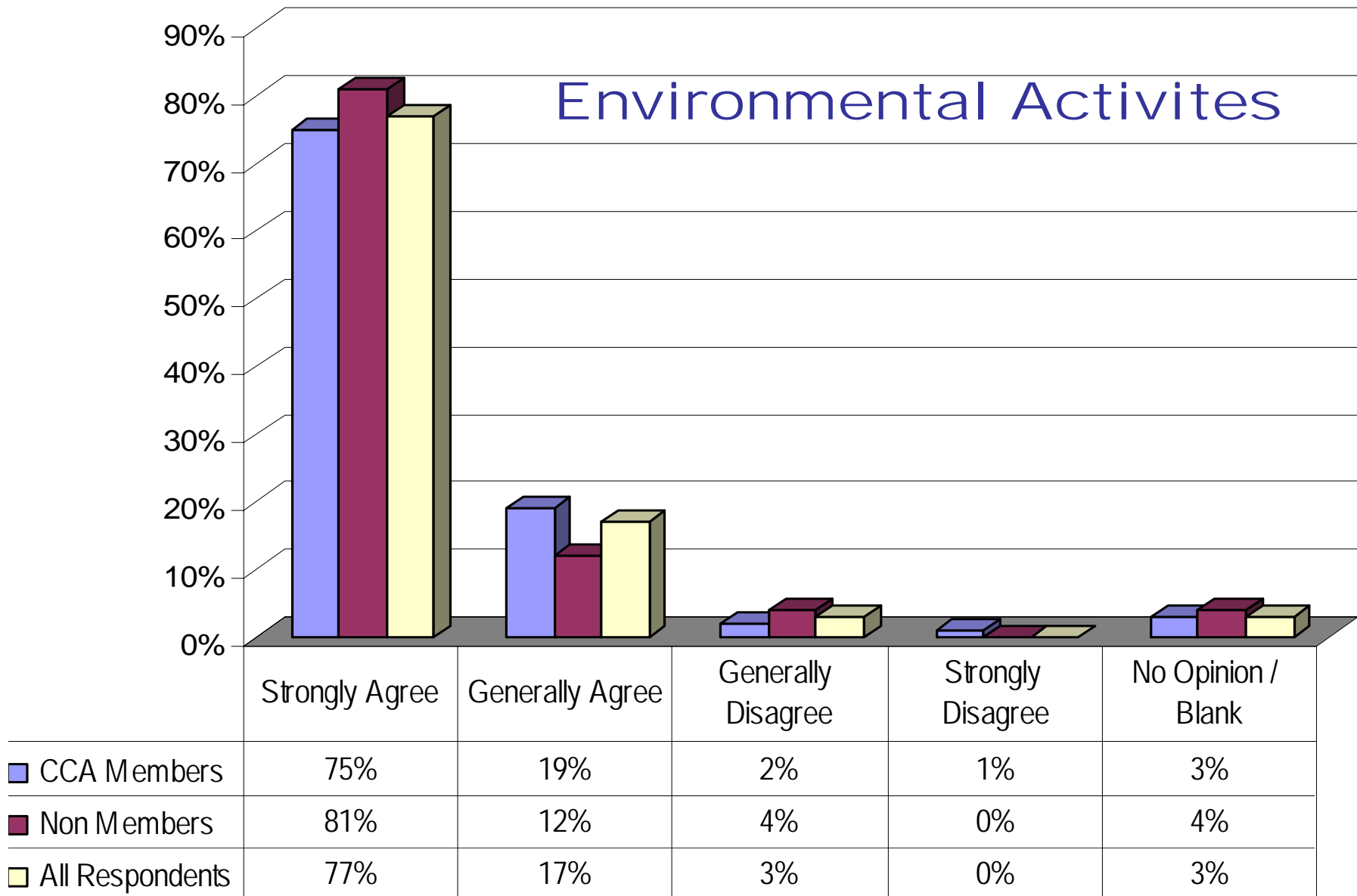
Environmental Activities Agree or Disagree?

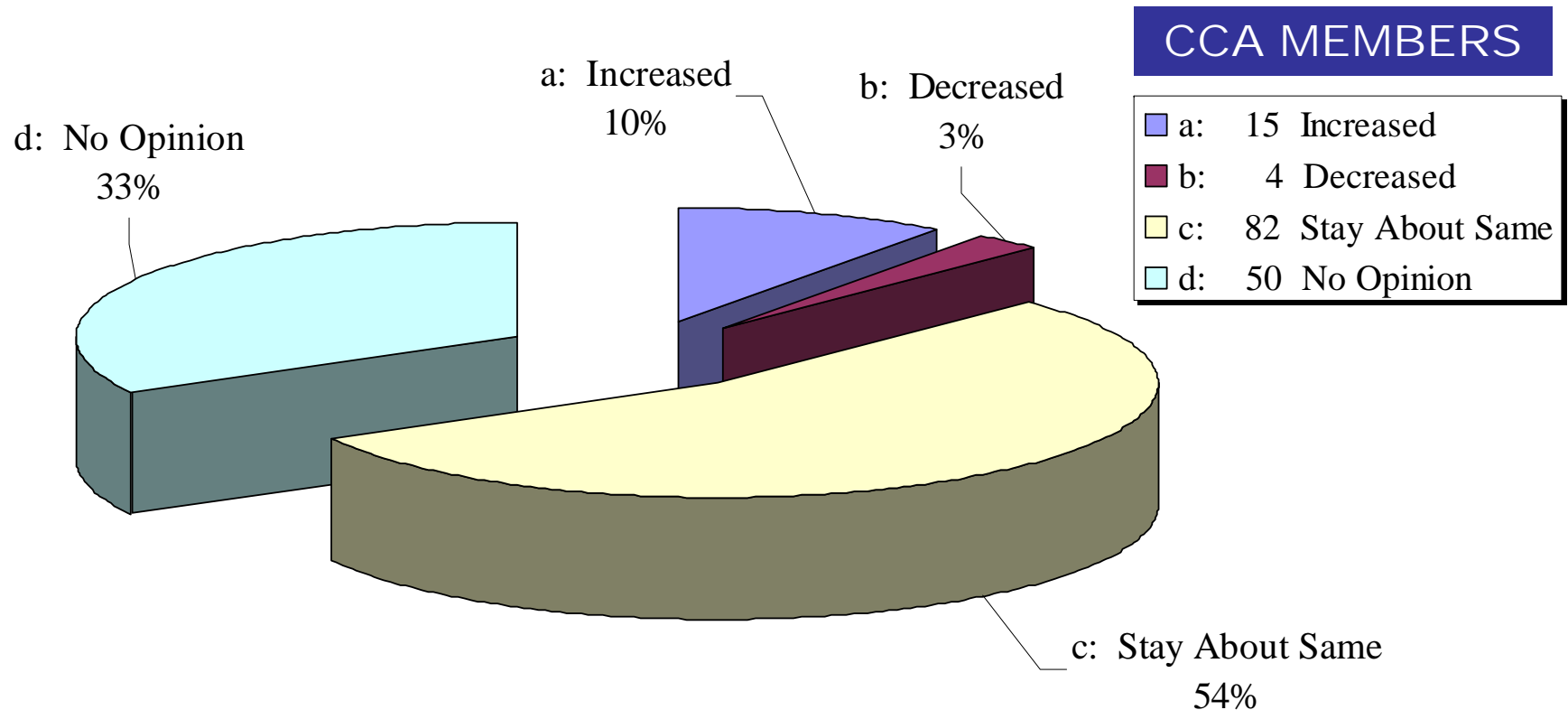

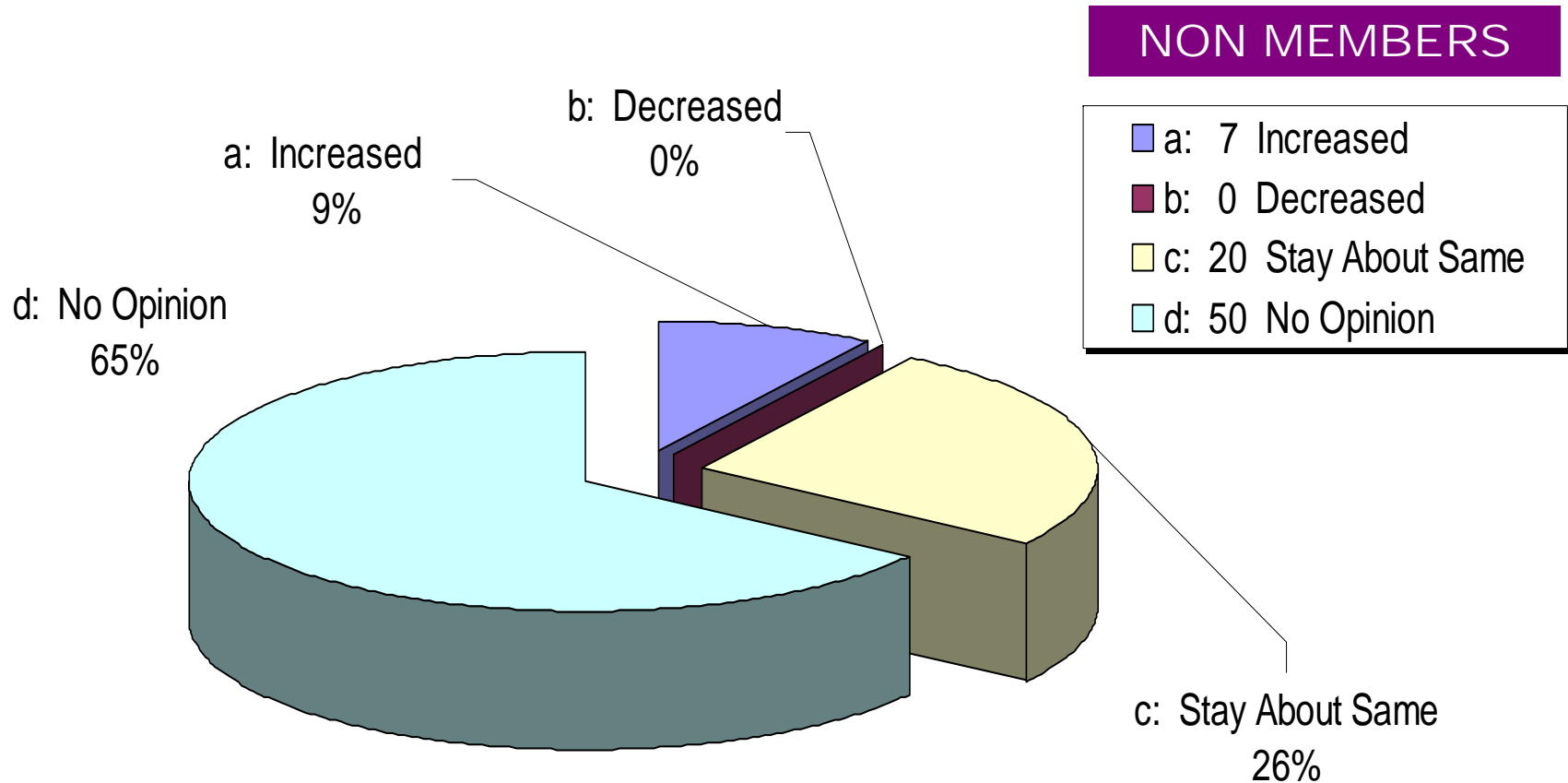

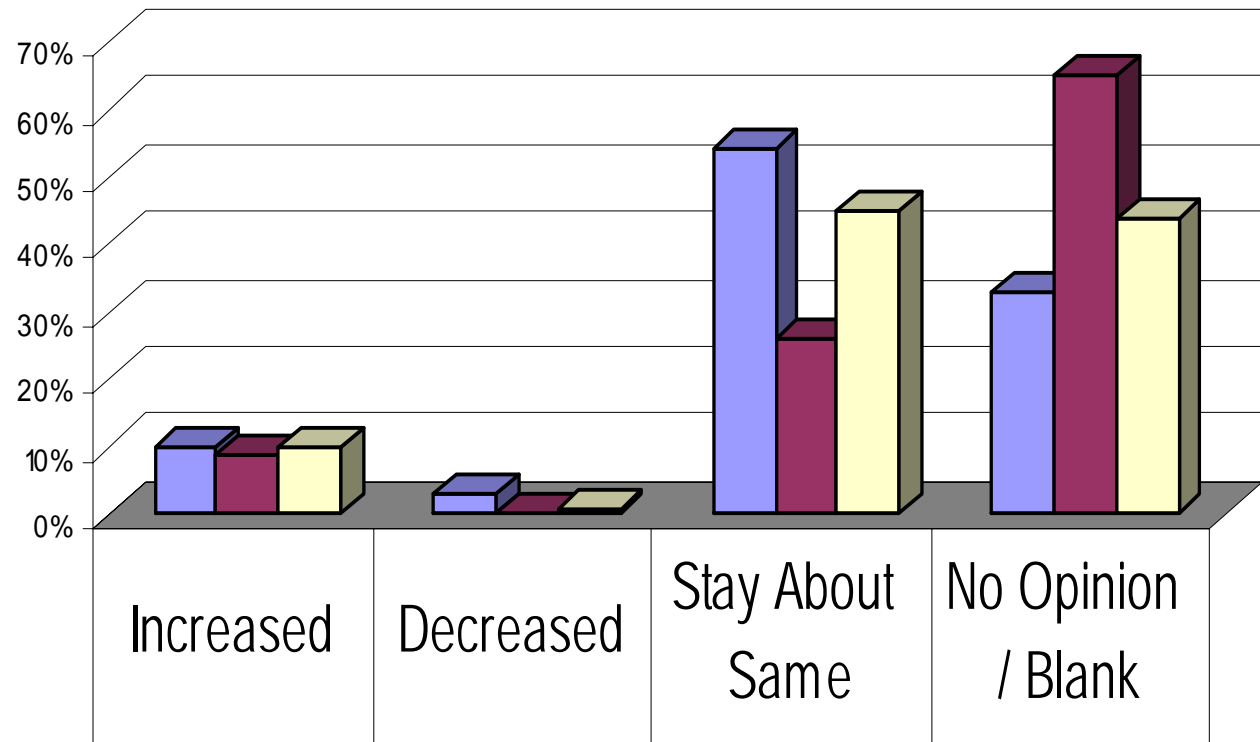

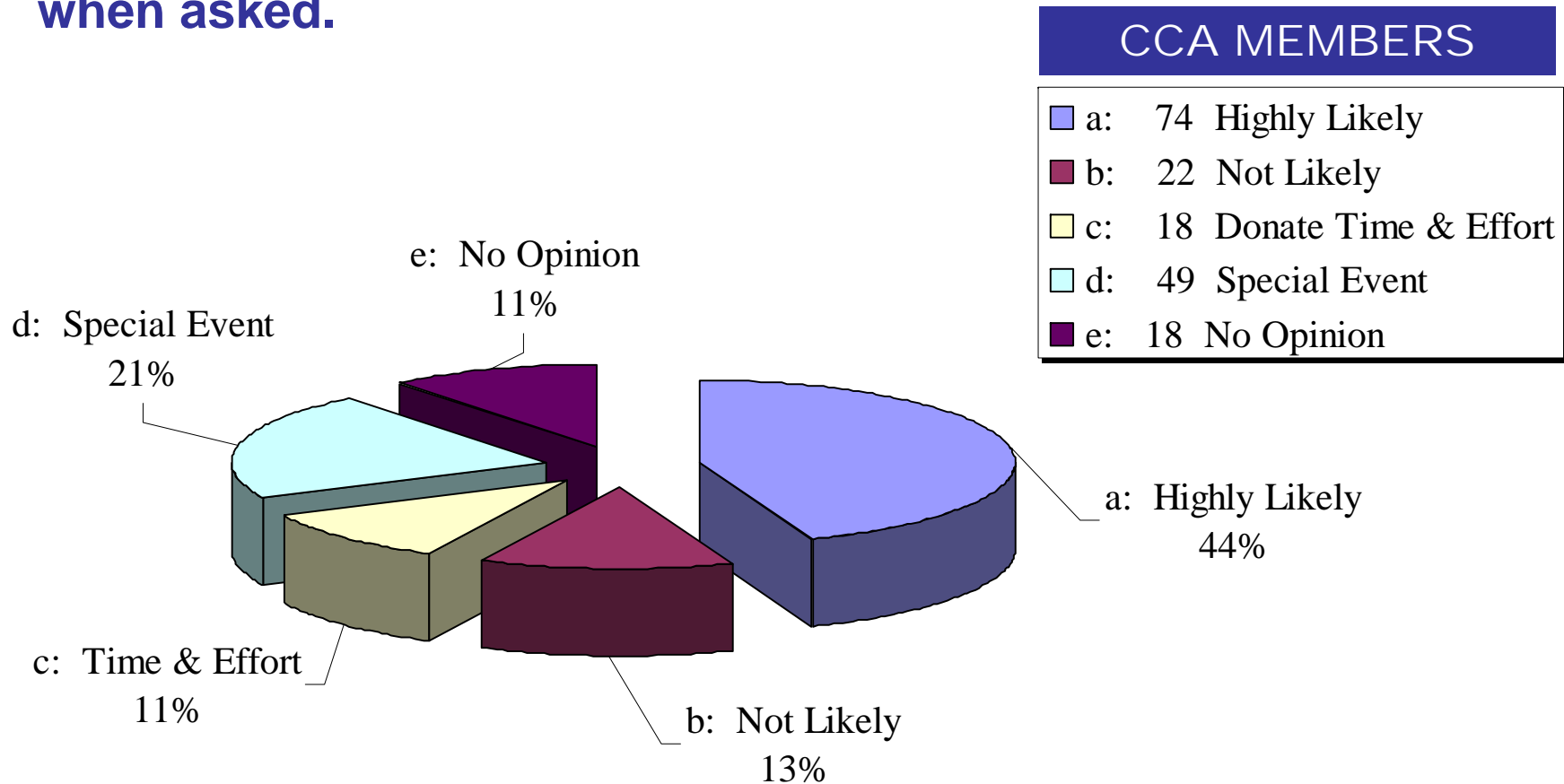

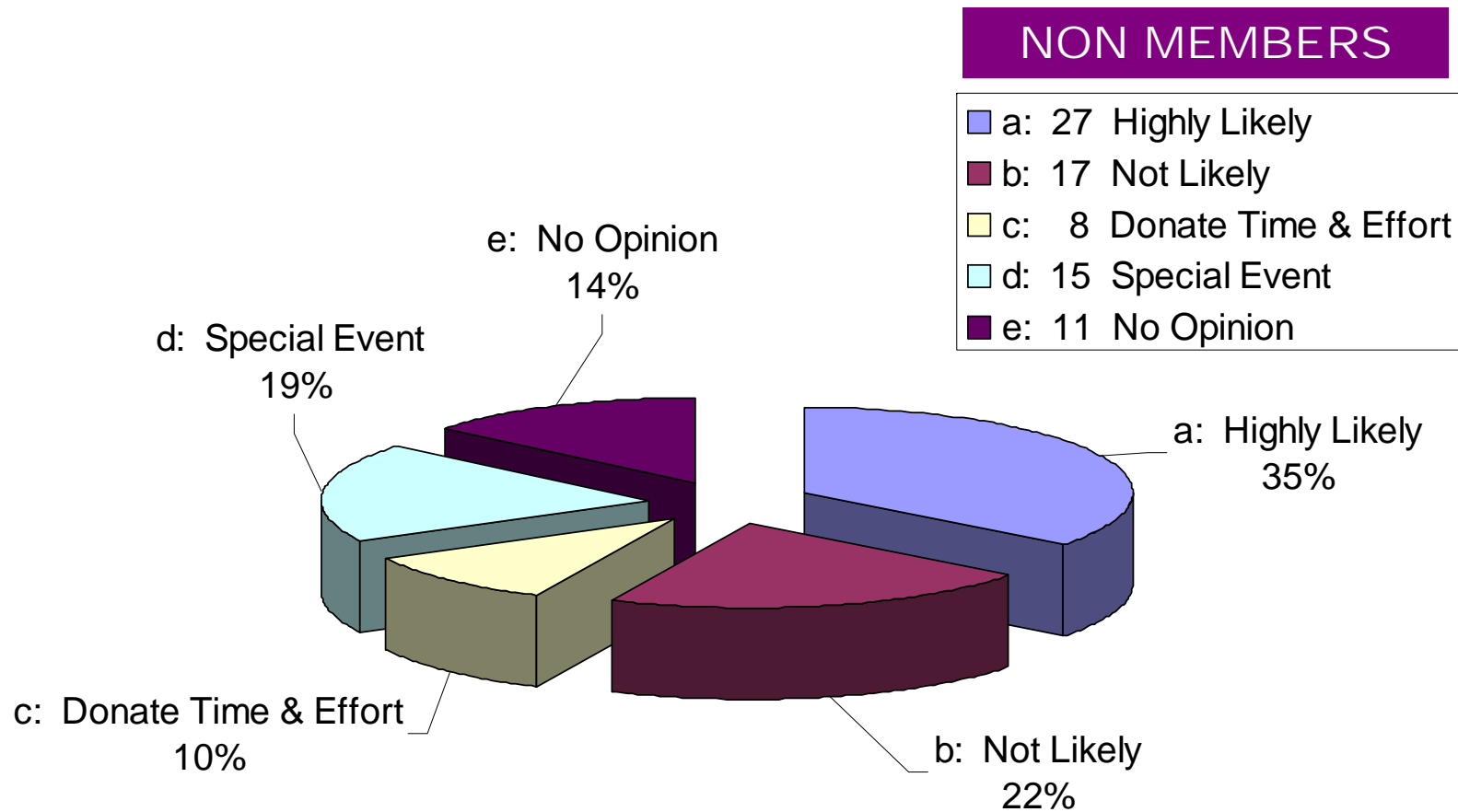

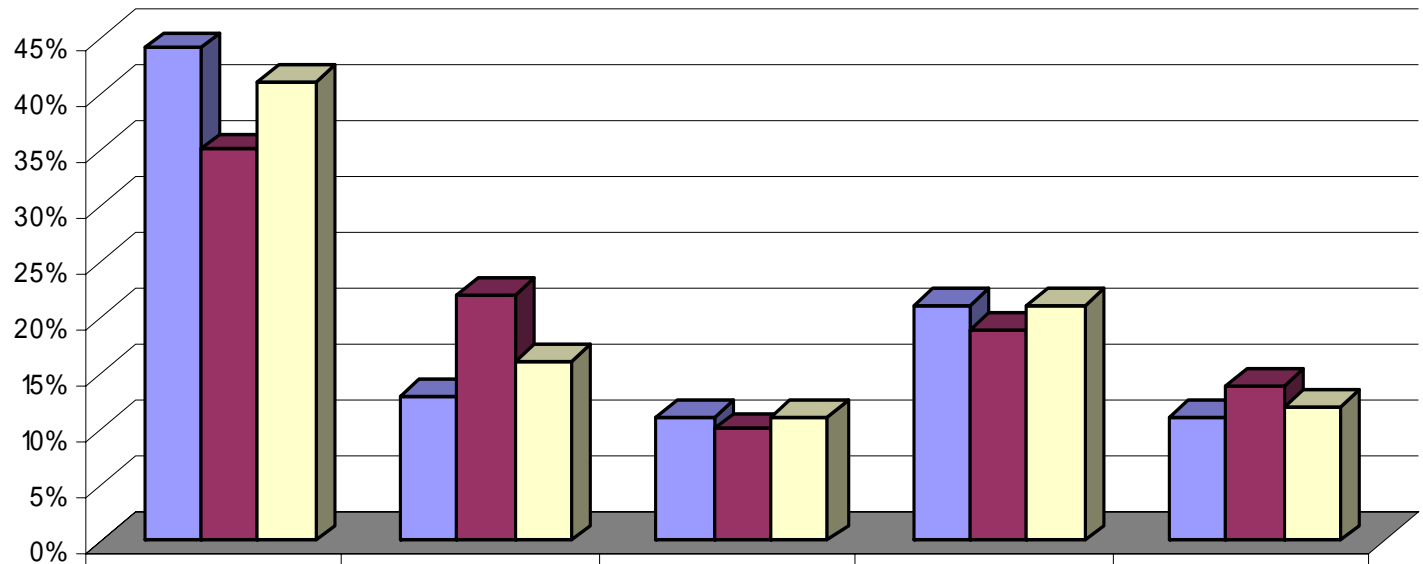

These approximate 145 issues listed by 106 members are divided into 12 categories and ranked according to rate of occurrence.

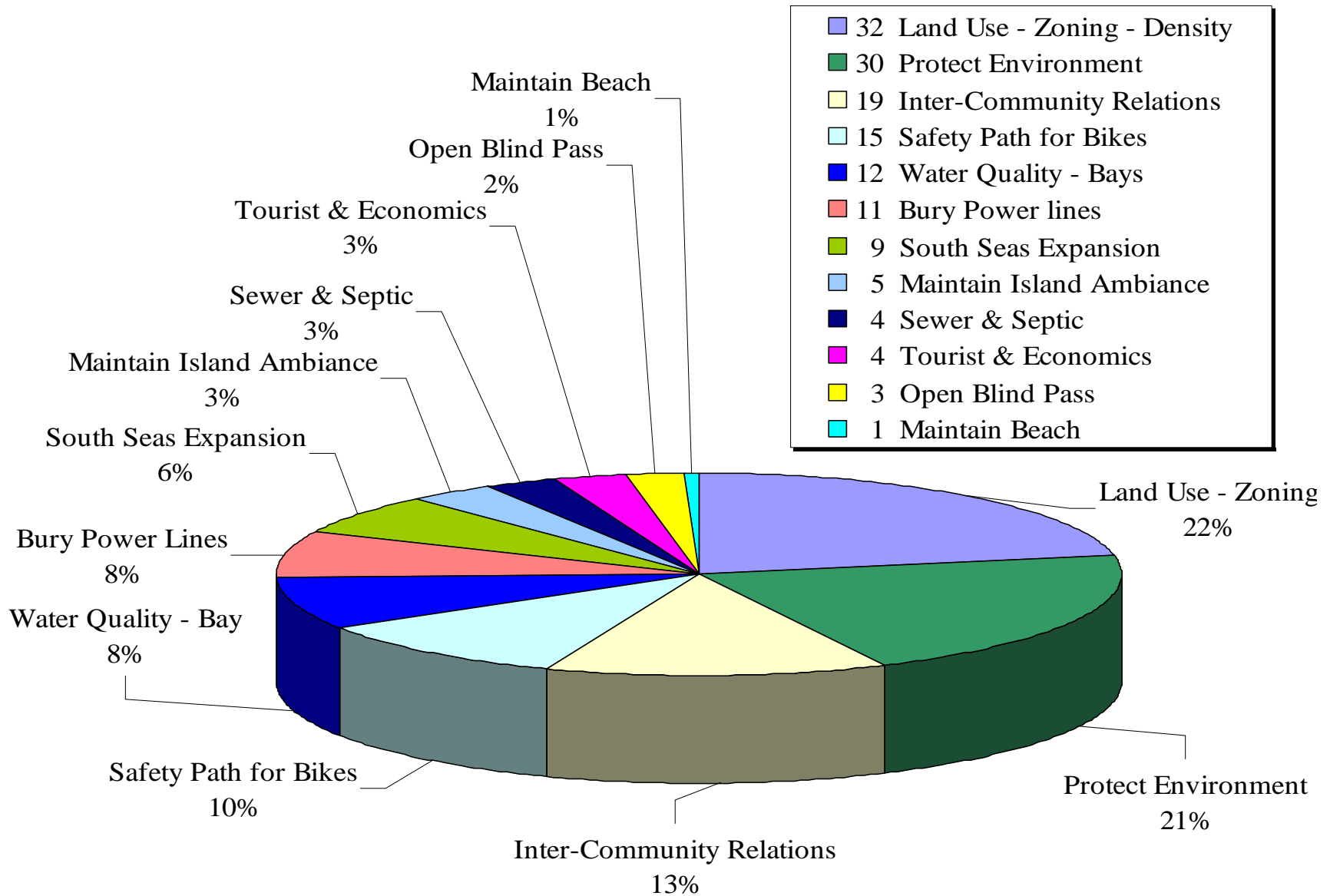

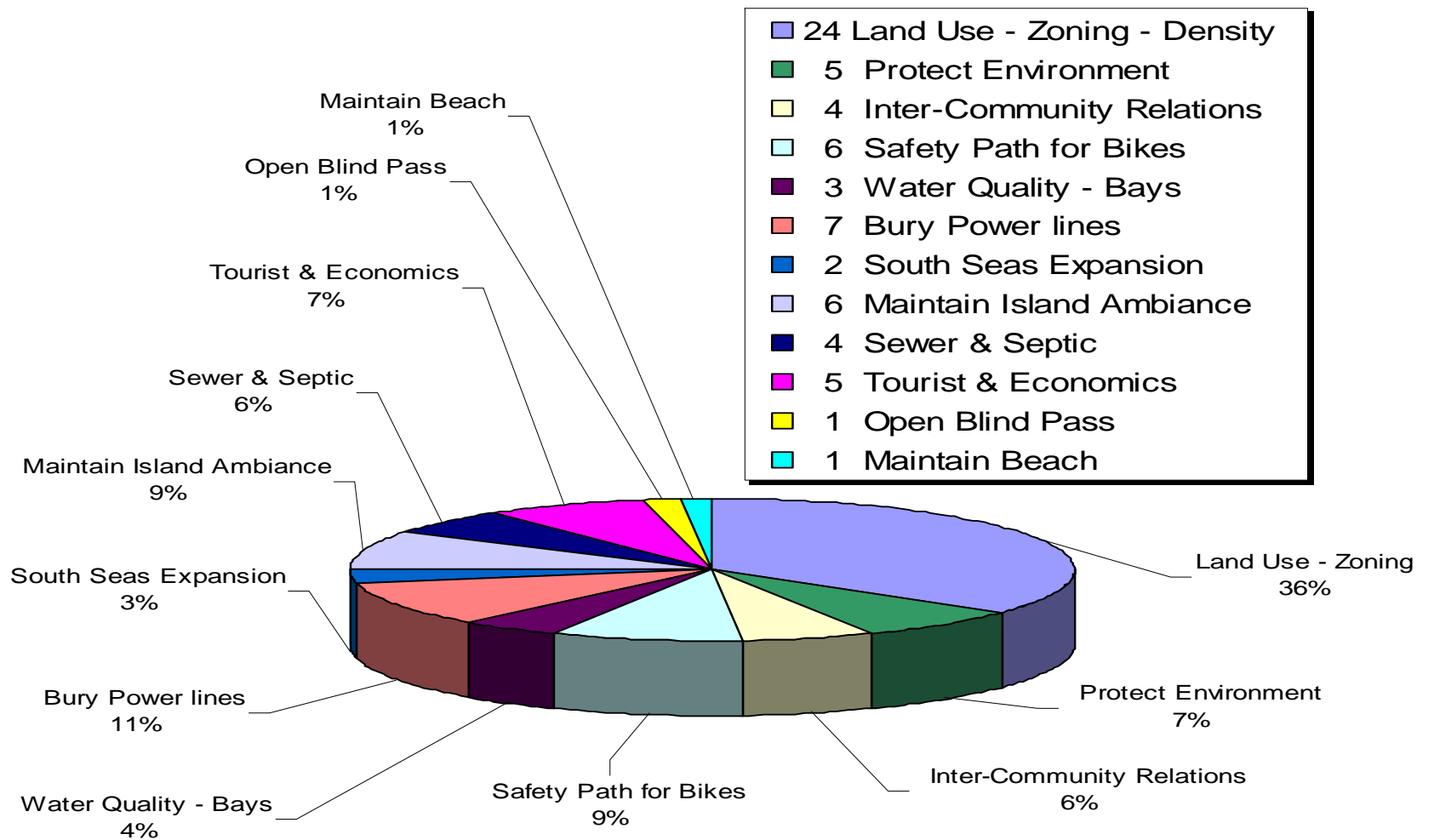
106 of 151 (70%) CCA Member Respondents offered comments as to what they believe are the most important issues for the CCA to address, resolve and place high on its list of priorities.

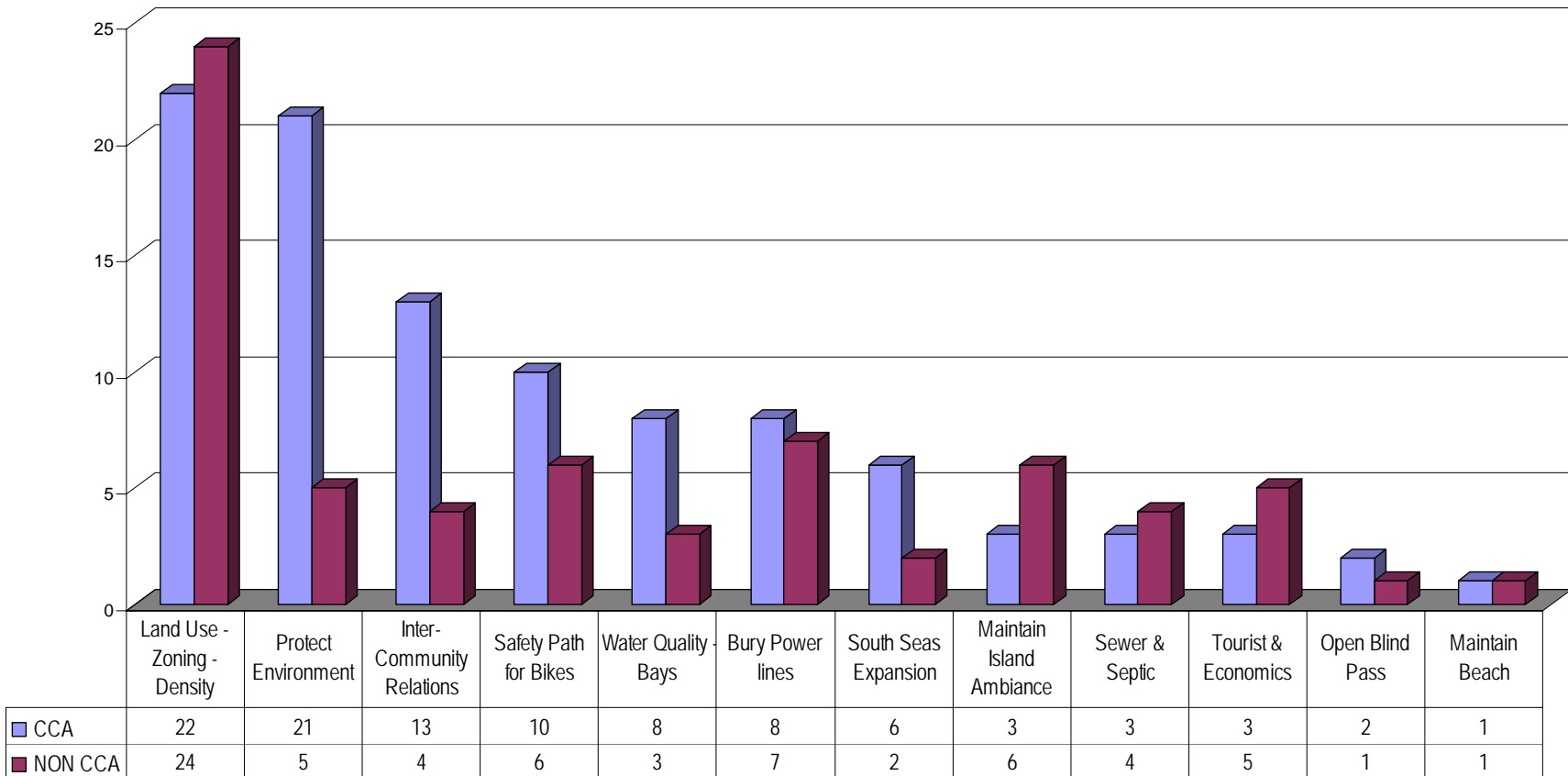
CCA Members' Most Important Issues Facing the CCA
